Moving into the Moving Image

uring the past year, the Oklahoma City Museum of Art has acquired its first two moving image works for exhibition in the Museum's permanent collection galleries: Andy Goldsworthy's *Hedge* crawl, dawn, frost, cold hands, Sinderby, England, 4 March 2014 (2014) and Apichatpong Weerasethakul's *Fireworks (Archives)* (2014). Together they represent the extraordinary possibilities the comparatively new medium of the moving image presents for the visual arts.

The first, Hedge crawl..., presents a painstaking, eight-minute performance by one of the greatest practitioners of environmental or land art, British artist Andy Goldsworthy. He is best known for his temporary landscape installations, created from leaves, twigs, ice, or whatever else is available in the natural world. Goldsworthy's art, at times, lasts for only a moment or

two, and for many is known only through photographs of the installations or the two films that have documented his unique process.

Goldsworthy's Hedge crawl..., which the artist's daughter and collaborator filmed, records the middleaged artist's laborious climb, suspended in mid-air, through a long row of brambly hedges in late winter. The artist's "performance" or artistic act would be lost to the world without this video documentation, and it is precisely the unedited depiction of time that gives this video meaning-along with the incredible physical effort required to complete the act. Something as simple as climbing from one side of the screen to the other becomes a matter of suspense and narrative, even as we empathize with the pain that we imagine Goldsworthy experiences.

The Museum's second moving image acquisition, Apichatpong Weerasethakul's Fireworks (Archives) explores a different, though no less essential, dimension of the young art form. In this work, a highlight from the Museum's acclaimed 2018 special exhibition, Apichatpong Weerasethakul: The Serenity of Madness, we watch as two Thai actors explore a Buddhist monastery filled with animal folk statues. Shot at night by the world-famous filmmaker and artist, Fireworks (Archives) relies on the flickering light source of the title to illuminate what is otherwise hidden under the cover of night. Weerasethakul is giving us many of the most fundamental aspects of moving image art, in their most distilled forms: light, space, sound, and of course, movement.

If *Hedge crawl*... gives the viewer a primitive, but powerful, form of story in Goldsworthy's act, Fireworks (Archives) shows us what moving image can look like without even the smallest degree of story, narrated through a walk rather than a climb.

Hedge crawl... was purchased in October 2017, and Fireworks (Archives) June 2018. Both will be on view in 2019's From the Golden Age to the Moving Image: The Changing Face of the Permanent Collection.





A Second Transformative Acquisition of Modern Art from Washington

In 1968, the Oklahoma City Museum of Art's predecessor, the Oklahoma Art Center, made a purchase that forever changed the course of this Museum. Following the closure of Washington, D.C.'s first collecting institution dedicated to contemporary art, the Washington Gallery of Modern Art (WGMA), leaders of the Art Center purchased the entire collection of that institution for \$110,000. Today, many of this city's finest examples of Modern art come from that collection and were the focus of 2018's celebratory exhibition, *The New Art: A Milestone Collection Fifty Years Later.*

One of the highlights of both the WGMA collection and *The New Art* exhibition, Paul Reed's *Number 17* (1964) was featured previously in the Museum's exhibition, *Matisse in His Time: Masterworks of Modernism from the Centre Pompidou, Paris* in 2016. Following that exhibition, the Museum began a relationship with the Paul and Esther Reed Trust, which culminated in the gift of 125 works by Paul Reed to the Oklahoma City Museum of Art.

Paul Reed was one of the leading Washington Color painters, one of the first significant Modern art movements in the United States that was centered outside New York City. The WGMA collected *No. 17* during the 1960s and featured it in their groundbreaking *The Washington Color Painters* exhibition in 1965.

Reed was a close friend to many others in the movement, especially OKCMOA artist Gene Davis, who was also recently featured in *The New Art.* To this day, the work of the Washington Color painters remains one of the most art-historically significant areas of the permanent collection.

This major new acquisition includes nearly fifty works from the 1960s, the period upon which the artist's reputation continues to rest, and other examples from every period of the artist's amazing career. Thanks to this truly transformative gift by the Paul and Esther Reed Trust, the Oklahoma City Museum of Art now possesses the definitive collection of Reed's extraordinary art. The legacy of the WGMA acquisition lives on in this latest 125-work milestone collection.

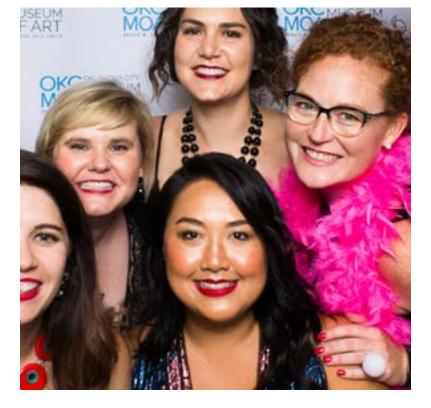

WHAT MADE YOU DECIDE TO BECOME A MEMBER OF THE **OKLAHOMA CITY MUSEUM OF ART?**

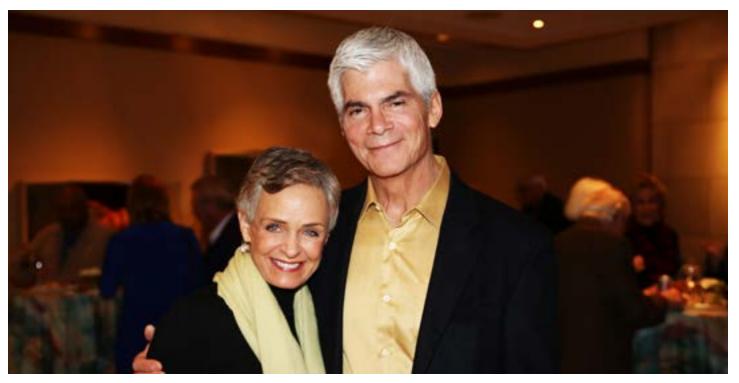

I did a painting of the view from her balcony depicting the Oklahoma City skyline, which included the current Museum site – at that time nothing more than the old Center Theatre. The current Museum is a major architectural contributor in what is now known as the Arts District.

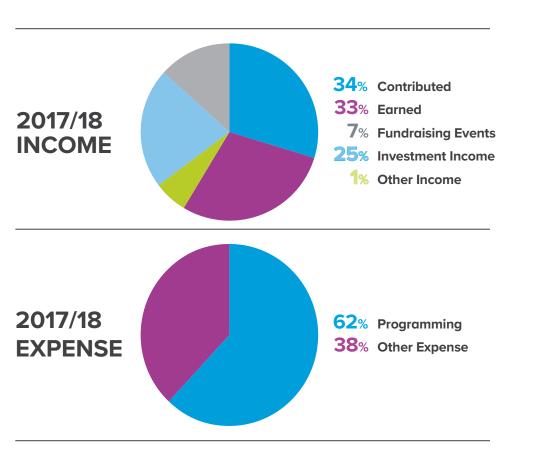

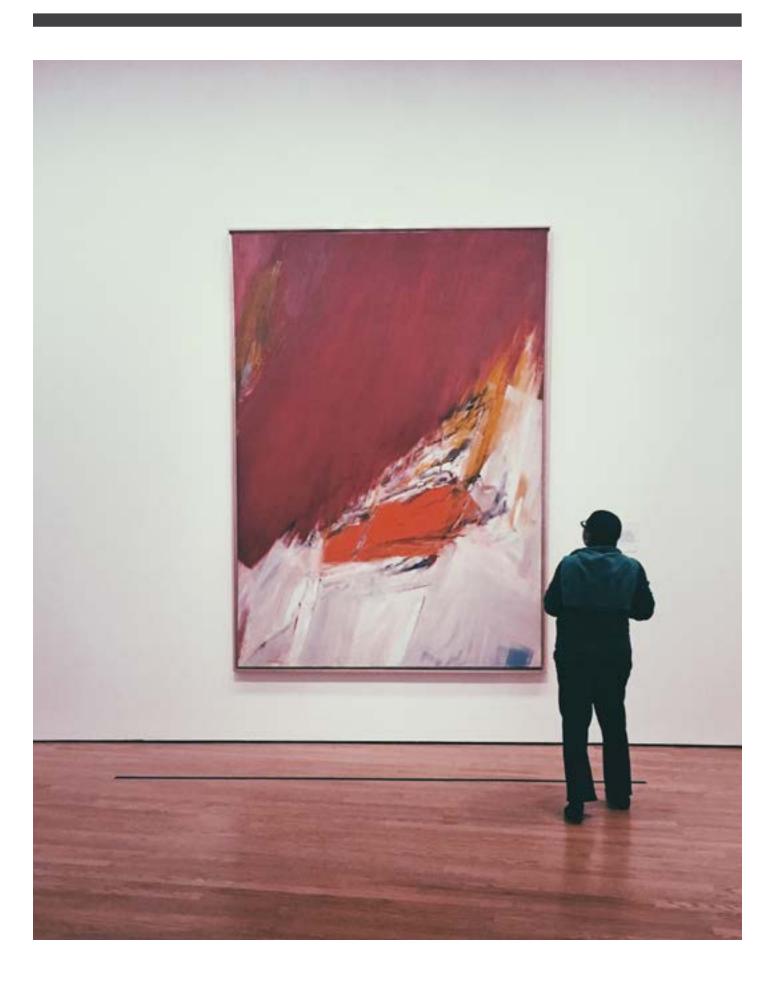
